5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Mercury House, Station Road, Richmond, North Yorkshire, DL10 4JX by 5 pm on Monday, 15th April 2019.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Mercury House, Station Road, Richmond, North Yorkshire, DL10 4JX by 5 pm on Wednesday, 24th April 2019.
