# **Examination Statement - Richmondshire Local Plan Core Strategy**

The purpose of this statement is to clarify the Environment Agency's position in relation to Richmondshire Local Plan Core Strategy (LPCS). Subsequent to our formal response to the Council's LPCS proposed Submission (August 2012) submitted on the 14 September 2012, further discussions have recently taken place with Richmondshire District Council resulting in the resolution of Water Framework Directive concern regarding the soundness of the document that we had raised in our formal response.

We can confirm that we have reached a position where we are satisfied that the soundness issue raised in representation reference 9112 has now been resolved. Further detail is given below.

# Background

Throughout the various consultation stages associated with the preparation of the LPCS, we were concerned that the Strategy may not be found sound if Richmondshire District Council had not made clear how the Water Framework Directive (WFD) had been considered in drawing up policies for the Core Strategy. Without this clarification, we considered that the soundness of the Core Strategy in relation to its conformity with the National Planning Policy Framework could be called into question

Subsequently, the policy team at Richmondshire District Council and the Environment Agency have created a joint statement with agreed minor amendments relating to the consideration of WFD. Unfortunately the Proposed Core Strategy Modifications document dated November 2013 preceded the joint statement.

Nevertheless we can confirm that our concern relating to issue of soundness raised in 9112 of our submission consultation response dated 14 September 2012 is resolved.
