# Richmondshire Local Plan Core Strategy: Proposed modifications, June 2014

## 1. Subject Matter and Area of Coverage:

- 1.1 Richmondshire District Council submitted its Local Plan Core Strategy for independent examination on February 28 2013. The Core Strategy is the main part of the new Richmondshire Local Plan and contains the Council's vision, spatial principles, sub area strategies and core policies to guide development up to 2028 in the area of Richmondshire outside the Yorkshire Dales National Park. Examination hearings took place between 11 and 14 February 2014. Modifications were proposed during the hearings and are published for statutory representations to supplement representations received on the remainder of the document when it was initially published in July 2013.
- 1.2 The publication of the Local Plan Core Strategy Modifications updates the Submission draft of the Local Plan Core Strategy, published August 2012. The proposed modifications address factual changes, detailed issues raised in statutory representations and modifications required by changing national policy and guidance. Some policies have been remodeled to improve clarity but not affecting policy content or purpose. The publication of the Local Plan Core Strategy Modifications does not invite comments on any other aspect of the Local Plan Core Strategy.

#### 2. Representations:

2.1 The Local Plan Core Strategy Modifications can be downloaded from the Richmondshire District Council website

- 2.2 Representations on the Local Plan Core Strategy Modifications should be made either in writing to Community Development, Richmondshire District Council, Mercury House, Station Rd, Richmond, DL10 4JX or by email to <a href="mailto:localplan@richmondshire.gov.uk">localplan@richmondshire.gov.uk</a> to be received by 5pm on Tuesday 29 July 2014. Late representations and representations on issues not relating to the modifications will not be accepted.
- 2.3 The purpose of the examination is to consider whether the Council's development plan complies with the legal requirements and is 'sound'. Legal requirements concern the way in which the Council has prepared its plan. Soundness concerns the content of the document and whether it has been is positively prepared, justified, effective and consistent with national policy. These terms are explained below.
- 2.4 Relevant representations should make it clear how the Council's modifications satisfy the legal compliance and soundness checks set out below and be supported by evidence showing whether the modifications should be changed and any suggestions about how they can be changed. Any representations received will be considered by the Planning Inspector alongside the published document and the representations already received by the Council.

### **Legal Compliance**

- 2.5 The Local Plan Core Strategy document should meet the legal requirements under s20(5)(a) of the Planning and Compulsory Purchase Act 2004 and the Localism Act 2011. You should consider the following before making a representation on legal compliance:
  - The document should be within the current Richmondshire Local Development Scheme (LDS) and the key stages should have been followed in its preparation.
  - The process of community involvement for the document in question should be in general accordance with Council's Statement of Community Involvement (SCI).
  - The document should comply with the Town and County Planning (Local Planning) (England) Regulations 2012. The Council must publish the documents prescribed in the regulations, make them available at its principal offices and on its website, place a local advertisement and notify general and specific consultation bodies (as set out in the regulations) and any persons who have requested to be notified.
  - The Local Planning Authority is required to provide a Sustainability Appraisal Report when it publishes a local plan, which is a tool to ensure policies reflect local social, environmental, and economic factors.

 The document must have regard to any Sustainable Community Strategy for its area (i.e. The Sustainable Community Strategies for North Yorkshire and Richmondshire).

#### Soundness

- 2.6 A sound local development plan should be positively prepared, justified, effective and consistent with national policy (NPPF paragraph 182)
  - Positively prepared The plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development.
  - Justified The plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence
  - Effective The plan should be deliverable over its period and based on effective joint working on cross-boundary strategic priorities
  - Consistent with National Policy The plan should enable the delivery of sustainable development in accordance with the policies in the National Planning Policy Framework.
- 2.7 Representations may be accompanied by a request to be notified of:
  - the publication of the recommendations of the person appointed to carry out an independent examination of the local plan under Section 20 of the Planning and Compulsory Purchase Act 2004, and
  - the adoption of the local plan.
